WANTED for FRAUD

Reward Concerning Information Leading to Arrest
of Ex-President Masaru Ishi (石井優) of Kinmirai Tsushin Co., Ltd.

1 Objective

Masaru Ishii (石井優), ex-president of Kinmirai Tsushin Co., Ltd. (株
近未来通信) (see photographs) and alleged mastermind of Kinmirai Tsushin
Fraud Case has been wanted for arrest under international warrant. He
left Japan in November, 2006 and believed to have entered China. The
Legal Team for Victims of Kinmirai Tsushin (hereinafter referred to as “the
legal team”) is seeking for information leading directly to arrest of Masaru
Ishii. Any minor information may lead to the arrest. Please provide any
relevant information to the legal team for victims.

2 Term of Limitation

The end of December, 2015 or the date of Ishii's arrest, whichever
comes first.

3 Qualification to Provide Information to the Legal Team

Any person having information that may directly lead to arrest of
Masaru Ishii is eligible to provide the information to the legal team.

4 Methods to Provide Information to the Legal Team

- (i) By postal mail, e-mail, or fax, to “the Legal Team for Victims of
Kinmirai Tsushin” together with your contact information.
(We cannot accept information by telephone.)
- (ii) Contact your local police station in China. (Any judgment
concerning reward payment is by the legal team as described
in sec. 5 below.)

Note: We surely welcome your information under anonymity, but reward
payment will be unavailable.

5 Reward Payment

Among those who have provided information concerning Masaru Ishii, the person whose information has most directly contributed to his arrest is eligible to receive the reward.

When two or more people have provided information with same degree of significance in terms of direct contribution to the arrest, the total sum of the reward is divided equally among such persons by the legal team.

Whether your information has directly led to Ishi's arrest or not is determined by lawyers of the legal team.

Please note, in case the legal team reasonably judge the person has breached law(s) of Japan or China to acquire the relevant information, he/she is disqualified to receive the reward. In addition, if the person is under alias or anonymity and unidentifiable, the legal team is unable to make reward payment.
